These actions are effective April 1, 2009. Debbie Anderson, Senior Personnel Specialist, of the Classification and Compensation Section of the Division of Personnel presented the proposal.

## DEPARTMENT OF HEALTH AND HUMAN RESOURCES

Upon motion of Ms. Lynch, seconded by Ms. Walker, the State Personnel Board approved a modification of proposal #2498, which exempted the position of SBIRT (Screening, Brief Intervention, Referral, and Treatment) Clinical Project Director under the provisions of *West Virginia Code* § 29-6-4(c)(9):

"Persons employed in a professional or scientific capacity to make or conduct a temporary and special inquiry, investigation or examination on behalf of the Legislature or a committee thereof, an executive department or by authority of the governor...".

The exemption is for the five-year duration of the federal grant and begins with the hire date of the exempt employee. The Board also approved the Division of Personnel's staff recommendation that the Department of Health and Human Resources use an appropriate existing job classification for the position. Tari McClintock Crouse, Assistant Director for Employee Communications and Information, presented the proposal.

Tari Crouse asked that proposal #2499 be withdrawn per Director Cox's request.
