PROPOSALS

3088-A Department of Homeland Security - Division of Corrections and Rehabilitation

3101 Department of Homeland Security - Division of Corrections and Rehabilitation

Upon the motion of Jay Arceneaux, seconded by Jim Dissen, the SPB voted and approved the proposal to convert a vacant classified position, classified as Corrections Program Manager 4 (8904), to a classified-exempt position.

3102 Jefferson County Health Department (JCHD)

Upon the motion of Jim Dissen, seconded by Jay Arceneaux, the SPB voted and approved the proposal to increase the special hiring rates for the Sanitarian 1 (9930) and Sanitarian 2 (9931) classifications and implement a retention incentive for the Sanitarian 1 (9930) classification at the JCHD.
